Case Study

Enhancing Safety at Newington College's Taylor Sports Centre

2020 Fire Protection partnered with Newington College to upgrade fire detection and emergency communication systems in the Taylor Sports Centre, ensuring enhanced safety and streamlined emergency responses for students and staff.

The Challenge

Newington College required an upgrade to the fire detection and Early Warning Intercommunication Systems (EWIS) within the Taylor Sports Centre to improve emergency response capabilities. The existing systems needed integration with the school's broader network to allow centralized control and ensure the safety of occupants during emergencies.

Our Solution

We installed a Notifier 3030 fire detection system, integrating it into the school's existing network. Xtralis OSID beam detectors were deployed in the sports courts and pool areas. Additionally, a Notifier I-2000 EWIS was added, enhancing the emergency communication infrastructure and allowing for comprehensive coverage throughout the facility.

The Result

The upgraded systems enabled a successful full-school evacuation and lockdown test, with all individuals accounted for. The main Fire Indication Panel (FIP) now offers site-wide control, allowing isolation of individual buildings while keeping others operational. The integrated system also facilitates manual operation of warnings and public address announcements, including a site-wide lockdown feature accessible from any panel.

With multiple service divisions under one umbrella, we offer seamless coordination across fire, HVAC, plumbing, electrical and pumps—keeping your essential services efficient, compliant and under control.
